This includes plagiarism, forgery, use or presentation of other researcher's work as one's own and fabrication of data. Fraudulent projects will fail to qualify for competition in affiliated fairs and the Regeneron ISEF.

The Society for Science, ISEF, WSSEF, CSRSEF, EWRSEF, MCSF, DRSEF, SWRSEF and NWRSEF reserves the right to revoke recognition of a project subsequently found to have been fraudulent.

Furthermore, in collaboration with the WSSEF Student Standards & Ethics Policy, in the event WSSEF, CSRSEF, EWRSEF, MCSF, DRSEF, SWRSEF and NWRSEF have paid registrations, fees or other expenses for a student found in violation of the above policy such expenses are repayable to the respective Fairs (WSSEF, CSRSEF, EWRSEF, MCSF, DRSEF, SWRSEF and NWRSEF) by the student and/or their family.
